Sushil Pokhrel (Chair) Ambika Dulal Avishek Gazmere Ichha Poudel Samjhauta Rai This is the second Annual report by Bhutanese Australian Association of South Australia (BAASA) presented at the Second Annual General Meeting held on 4 August 2013 in Adelaide. The report comprises details of activities carried out between 1 July 2011 and 30 June 2013.

#### SGP program

BAASA received few smaller grants in the period July 1, 2011-June 30, 2013 besides the SGP under the management of Australian Refugee Association. Because of the nature of the SGP grant that all financial management is controlled through, we are not liable to report about the financial report of the SGP grant for the year 2011-2012. Since 2012 BAASA has not received SGP grants despite we applied for 2012-13 and 2013-14.

One of the components of the SGP grant was casework, helping the newly arrived Bhutanese families and individuals in range of issues. During the second SGP grant period, BAASA community workers did 83 caseworks. This is almost double of the target made during the commencement of the grant.

BAASA was able to offer information to 200 clients about various services who are in need. The information sessions and one-to-one services immensely helped the newly arrived community members in getting support and services from the government and social institutions. The project was successful in bringing about the more mature attitude towards settling in Adelaide. BAASA helped meet their expectation line up with reality and reassuring them there is support to become self-sufficient.

Against targeted 100, BAASA referred 160 clients, coming to seek assistances, to various others service providers. BAASA office located at the ARA office in Underdale provided information to clients on services provided through BAASA-ARA cooperation. BASA referred most clients to ARA's help desk who seek financial assistance to pay their utility bills. Similarly, BAASA referred clients to ARA for services like homework support, accommodation support service, employment support service and ARA computer donation service to obtain the cheap computers.

Beside these services BAASA was able to refer the clients to outside help seeking places for various help. Many clients were referred to St. Vincent De Paul to get furniture to fulfil the requirement of the furniture at their homes, Youth Jet and Baptist Care (FUSE Driving) for the assistance to get their driver licenses, MRC Northern Region (Salisbury) for various services and support for the refugees. Likewise many clients were referred to STTARS for getting help to erase off trauma.

BAASA was also able to refer the clients to various mainstream services providers to equip with basic knowledge so as to make their living easy. The following are the mainstream service providers: Birthline, Local Councils, Family SA, Housing SA, Educational facilities Uni. TAFE, St. Vincent De Paul, Salvation Army, Centrelink, Real Estate Agents, STTARS, SA Police, Scam Watch, MYSA, Baptist Care SA

BAASA organised seven swimming lessons for Bhutanese community members who recently arrived in South Australia. The swimming session was held in Marion Outdoor Swimming Centre in February-March 2012. Volunteer trainers were made available by the Centre to train the participants.

In average, 10 community members participated the swimming lessons. Eight lessons were held in the swimming centre while two sessions were held at Brighton beach. It was intended to train community members on beach safety and surfing.

BAASA as part of the SGP program organised outdoor camping for Bhutanese mothers on December 16, 17 and 18 2012. 15 mothers from the community experienced the first camping life at Deep Creek Conservation Park, about 110 km south of Adelaide, near the popular destination Victor Harbour.

This camping was targeted to give opportunity to our hard working mothers, who spend most of their time in kitchen and looking after children, to experience the outdoor life. BAASA organised tents and sleeping bag to sleep in while the participants carried pillow, blankets and a bed sheet and some comfortable shoe to do the Bush Walk. Mothers at the conservation park office learnt how to register themselves to enter park. A park officer talked to them about dos and don'ts in park.

Mothers also leant setting up camps with little support from project officer and volunteer. During the stay, they had a small session on Parenting presented by a worker from Migrant Resource Centre. She talked about how to take care of kids while camping.

BAASA under SGP grant organised several gardening workshops for eligible Bhutanese community members in September-December 2011. It is about making Veggie Patch or growing vegetables at backyard with appropriate method.



BAASA is collaborating with HEALS (The Health Education and Life Skills Centre) for this project. Paula and Laura facilitated the workshops where over a dozen Bhutanese community members were trained. The trainings were designed in such a way that participants can actually see results of their gardening efforts. The community members were given veggie patches where they plant and take home later when grown.

The participants are also taught to cook healthy food suitable to the climate.

Similarly BAASA coordinated with Bunnings Warehouse in Parafield to organise a free Do It Yourself (DIY) workshop for Bhutanese community members on vegetable gardens and fruit trees on 17 November 2011.

BAASA in cooperation with Department of Immigration and Citizenship (DIAC) organized information session on citizenship for Bhutanese community members.

Sofia Basic and Marg Calvert, two officials from DIAC in Canberra, facilitated the information session attended by over five dozen Bhutanese community members at Twelve25 Youth Center in Salisbury on 15 November.

#### Self-sustainability

After the new executives took over the responsibility in April 2012, efforts were made to generate funds at the community level. Several fund raising activities were conducted and planned for the future as well.

These fund raising activities were focused on meeting the financial needs while organising community events since the small grants that BAASA received were not likely to cover the costs occur. BAASA executives also aimed at building culture within the community members to look for alternate funding sources than expecting financial support from the government. The culture would help, the auspice groups, and many their projects financially sustainable.



BBQ sessions at Bunnings Warehouse in Prospect were the major ones. BAASA organised three sessions in Bunnings Warehouse in May and June 2013 as part of the fund raising events for soccer tournament scheduled for July 2013. BAASA also organised Table Tennis competition among Bhutanese community members in May 2013 also as fund-raiser event for the soccer tournament.

BAASA executives decided to provide the annual day platform as important occasion for the auspice groups for fund raising. In Annual Day IV, Yuba Sansar organised raffle and T-shirt sale while Bhutanese Ethnic School had placed donation box for voluntary contribution. The Adelaide Dragons had food stalls to raise funds for their travel to Brisbane to participate in the first Bhutanese interstate soccer tournament.

In Annual Day V, Yuba Sansar again did raffle as fundraiser while Bhutanese Youth Group (BYG) had a cultural food stall. BYG had donated most of the fund raised out of food sale to BAASA for the soccer tournament.

Other fund raising event was Nepali film Malatiko Bhatti in Adelaide. Actor Jiwan Luitel was present at the screening held at mercury cinema in Adelaide. The screening attracted moderate number of audience.

#### Facilities available

BAASA since 2011 has utensils for hire by community members in special occasions. The utensils are freely available for families mourning death of their relatives. Others are expected to contribute so that we will be able to continue the service in future.

BAASA has trailer facility as well to support the community members during housing relocation. Shifting house is one of the regular phenomenon taking place every year and a lot of money and time is spent on this.

BAASA also has PA system, which the community members and auspice groups can hire for smaller functions.

#### Consultations

SGP workers and BAASA executive committee members on 11 June 2012 held extensive discussion with the community volunteers at Twelve25 Youth Centre in Salisbury.

The volunteers discussed challenges and opportunities of volunteering for Bhutanese community members. It was finalised that a concrete policy, procedure and guidelines are required to build community volunteers.

Further, the volunteers and executive committee members reviewed the strategic direction formulated last year. It was realised that many activities mentioned in the plans were achieved, some underway while few others are yet to be initiated. Few projects initiated outside the plan were also discussed.

BAASA has formulated a strategic direction the previous year during a three-day extensive discussion held in Norton Summit.

At the initiation of BAASA executives, Bhutanese community members who are resettled in South Australia since 2008 held interaction with Australian Cultural Orientation (AUSCO) Trainer J. B. Rana Magar who was in Adelaide in third week of March 2012.

Rana is part of the orientation program run by International Organisation of Migration (IOM) in Nepal. Rana was a member of IOM orientation team for those preparing to fly to Australia. A total of 20 people attended the interaction.

Participants apprised the trainer for orientation that helped a lot while resettling in Australia. They also suggested several more areas where information is necessary for people resettling in Australia. Rana assured to include them in future orientations.

#### Language and Culture

BAASA continued to observe anniversaries of the leader Nepali literature figures. BAASA in association with International Nepali Literary Society (INLS) Australia celebrated Bhanu Jayanti in July and Laxmi Jananti in October 2011. After the formation of the Bhutanese Ethnic School, BEC has been endowed to uphold the literary activities in the Bhutanese community. Namaste Cultural Group is another entity operating as auspice group of BAASA. The group primarily focuses on promotion of Nepali folk songs and music. For more details, see their report.

#### Auspice groups

New Executives of BAASA took over responsibilities in April 2012. They replaced the previous committee working since the formation of the organisation in 2009. The Executive Board members work on volunteering basis.

The first AGM in July 2011 amended the constitution to reconstitute the executive committee of five members. Accordingly, the several desk existing at that time as part of the executive committee became irrelevant. The election of new executive committee was held under the amended provision of the constitution.

The new executive committee felt the need to amend the way different desk operational under the previous conditional provisions. Rather than asking/nominating one or few people to take responsibility of specific desk, the committee decided to go for the concept of auspice group. There were a few independent groups coming up and willing to seek support and guidance from the organisation. Without interfering the way they function and the decisions they make, the BAASA executives decided to extend all possible support they need in serving the community. BAASA executives also extend support in helping these auspice bodies connect with the relevant institutions and organisations, writing grants, find suitable trainings and provide other material support.

BAASA, being accountable to the funding body, will monitor the expanses from the grant money. The auspice body are expected to hold accountability for all the money they generate from fund raising events and community contributions.

Terms of Operation for Bhutanese Ethnic School has been finalised and we are working to have it with other auspice bodies as well. We aim to complete it before next executive committee takes over the charge.

#### Annual Settlement Day

The Annual Day the anniversary Bhutanese celebrate joyously of their entry to Australia. The 2012 Annual Day made special performance by the Rai community as an effort to showcase the diversity that exists within the Bhutanese community. There are many sub-communities in us and BAASA executives envision encouraging them to promote their culture and traditions in such special occasions.

2013 Annual Day was organised as a special occasion to say thank you to all our volunteers who have contributed significantly towards settlement of the new arrivals in the last five years. It was also the occasion to mark the first five years we called Australia our new home.



We also took the opportunity to convey our sincere thanks to the agencies, institutions and individuals who helped us to settle well in Australia in the last five years.

#### Partnership

New executive committee continued its efforts to extend the relation with government agencies, non-profit organisations and other multicultural communities along with the mainstream Australian communities.

BAASA is running a joint project with STTARS to educate the Bhutanese community members of the rights and responsibility in Australia. By end of June 2013, workshops targeting the senior members of the community have been completed. Workshops for young people were planned for July 2013.

By end of June. BAASA has reached an agreement with Anglicare SA to run special project to engage young people in creative activities and build in them the notion of positive living. The project funded by Youth Connect will hire two young individuals as part time employees to work on the project.

funding agencies and relevant stakeholder in digital form. The bulletin is available for download from the BAASA website. We have received 'very positive' response about the newsletter especially from the government and non-government organisations.

With funding from our Port Adelaide Enfield council for IT training, the newsletter was produced in hard copy with significant contribution by the young people who participated in the 10-day IT training.

The newsletter contains news about the Bhutanese community activities across Australia and New Zealand. It also contains literary creations, news from Bhutan, community notices, interviews and many more. The newsletter has become and important tool for promoting

community activities, connect Bhutanese community across Australia with the relevant stakeholders and let the community members know what BAASA has been doing.

#### Youth engagement

BAASA supported the enthusiasm of the young people to start a radio program. The weekly show Yuba Sansar has become effective not just inspiring young community members for active community engagement but also stand out as the best medium to circulate community information and notices. The program received national recognition in less than a year it came into existence. For more details, see the report by Yuba Sansar.

As envisioned and noted during the strategy planning session of the BAASA in April 2011, discussion among the visionary personalities in the community culminated into having a Bhutanese Ethnic School where young children would attend to learn read, write and speak Nepali language. The school has received applauses from the community members. The attendance in school is much higher than expectation.

A group of young people, who named their group as BYG. approached BAASA for support in their activities. They agreed to work as BAASA auspice group where BAASA provides support in linking them with relevant stakeholders. seeking funding. carrying out community activities and have



insurance for them. For details about their activities, see their report.

Over 20 young people attended a 10-day IT training in December 2012-January 2013 held at Enfield Community Centre and Youthjet office in Adelaide. The participants learnt about blogging, basic news writing, following community news, using social media for information sharing, designing and producing community newsletter etc.

Two soccer teams from South Australia participated in the interstate soccer carnival to be held in Brisbane. BAASA help raise funds for two teams of Adelaide Dragons to travel to Brisbane in July 2012 for the tournament. One of the team won the tournament.

Bhutanese soccer clubs from across states where Bhutanese live participated the competition.

About 400 people including the conferees attended the ceremony, held at Woodvile Town Hall on 16 June 2013. BYG received guidance from Ratan Gazmere throughout the process of planning and hosting the event. According to DIAC, it was the largest citizenship ceremony ever held in South Australia in such a grand manner. Immigration Minister Mark Butler MP awarded citizenship certificates to the conferees.

# Activity reports Activity 1: Securing funding

Yuba Sansar received funding of \$6,000 from Multicultural Youth South Australia (MYSA) under Multicultural Youth Development Fund (MYDF) from the Department of Communities and Social Inclusion.
